We are off to a great start with OC Conservation Corp, as we kicked off our Financial Literacy for Youth (FLY SoCal) Program. The FLY SoCal initiative, brought to you by Affordable Housing Clearinghouse (AHC), is designed to empower youths aged 16-24 in Orange County and Long Beach (SoCal) with critical financial knowledge and skills. Targeting justice-involved, foster, emancipated, and out-of-school youth, the program offers bilingual workshops on financial management, budgeting, and credit, alongside one-on-one counseling sessions. FLY SoCal's goal is to reduce economic motivations for crime and foster a sense of community responsibility by equipping participants with financial literacy.
